



Wedding contract, Terms and Conditions

It is mutually agreed that the following terms of agreement form an integral part of this contract and that no variation or modification of the contract shall be effective unless accepted by both MJDphoto and the client, in writing

Booking Deposit: A deposit / booking fee of £50.00 is required at time of booking, together with a signed contract. Dates are reserved only when this deposit is paid. Please make cheques payable to Mrs Dickens t/a MJDphoto or by Bank Transfer: HSBC, 70112399, 40-08-68. Unfortunately we are unable to accept credit or debit cards. An unconditional refund policy exists for a period of 14 days from receipt of this contract and payment.

Balance payment: A balance payment is to be made not later than 30 days prior to the Wedding Ceremony

Creative Licence: MJDphoto shall be granted creative and artistic licence in relation to the choice of locations and poses used. Our judgement on photographic style and the number of photographs taken, shall be deemed correct. Due to changes in weather and the availability and willingness of subjects MJDphoto will do their best to honour requested photographs but do not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.

Viewing: Proofs will be displayed in a secure guest area at www.mjdphoto.biz and password provided.

Refreshments: For full day service, provision must be made to provide refreshments eg a sandwich and a drink.

Exclusivity: MJDphoto shall be the sole professional (stills) photographers at the venues specified. We do however positively encourage family, friends and other guests to take photographs throughout the day.

Force Majeure: In the unlikely event of total photographic failure, injury or sickness beyond MJDphoto's control, their liability shall be limited to a full refund of all monies paid. Your statutory rights are not affected. MJDphoto has full Public Liability and Professional Indemnity Insurance.

Cancellation: If MJDphoto has to cancel this contract for reasons beyond their control (death, injury, sickness etc) their liability shall be limited to a full refund of all monies paid. Every effort will be made to find an alternative photographer. Should the client cancel, as compensation for loss of income for MJDphoto the following charges apply as a percentage of total fees due. (number of days before the wedding) 60 days or less – 100%, 61-90 days – 75%, 91-120 days – 50%. Should the cancelled wedding turn out to be a postponement, then, subject to availability, all money paid may be applied to the new wedding. In this case, the total fees chargeable shall be the fee which applies at the time. In the event of MJDPhoto taking another wedding booking for your cancelled or postponed date a full unconditional refund of your deposit and monies paid shall be made.

No images created as part of this contract may be copied or reproduced in anyway without our express prior permission.
